

I am very positive about the basic principles behind this research and I like the coherent theorising of professional identity that it includes. You have also Abstract: no need to include year of data collection (also in the method you say 2011 and 2012, so this appears incorrect). Abstract could be less wordy, e.g. Introduction: I feel there are still some really unsubstantiated points here. For instance, while it is a fact that many performers also teach, and while rese

Appropriate referencing is needed.

In the method there is a lot of detailed discussion of how you adapted various sections of existing measures, but if a reader is not familiar with these measures. the results you introduce the term diffusion, moratorium etc. These clearly relate to Marcia's theory of identity construction which I cannot find any refe In the analysis you report only data for the cluster analysis from the students who also had teaching experience. Surely this should be the final sample, rath In interpretation I think you still have a few too many assumptions. For instance, on page 31 you argue that (some) students may have a lack of suitable role Finally, I appreciate you have made amendments to the recommendations based on the reviewer's point that this was somewhat unsubstantiated and not based on you Smaller issues:

The English and the clarity of expression still need some checking.
E.g. abstract, research questions, should probably be 'what are the characteristics' not 'which'. 'was worked out' would be better as 'was developed'. You cou To make the sense clearer from the start, I'd suggest altering the next part to include the statement about performers and teachers within the same sentence, "Music researchers try to understand why music academy students choose to work as teachers." This sentence is unnecessary and could easily be deleted.

Teaching a music instrument allows the opportunity to find a compromise between the desire to become a professional performer and the need for a stable profes I could spend many hours editing the English/finer points of meaning like this, but unfortunately I do not have the time. However, while I do appreciate you l

Having picked not to choose page 25 - chosen (your original word) is much better.

If you have figures and tables in the manuscript they should be placed at the end with a note 'insert table 1 about here' - this is helpful for the typesetter
